Piedmont Lithium Limited (Piedmont or Company) and the entities it controls believe corporate governance is important for the Company in conducting its business activities.

The Board has adopted a suite of charters and key corporate governance documents which articulate the policies and procedures followed by Piedmont.

These documents are available in the Corporate Governance section of the Company's website, www.piedmontlithim.com. These documents are reviewed at least annually to address any changes in governance practices and the law.
